Terms and Conditions for Purchase and Use of Images Agreement

GENERAL:

1. By receiving and reproducing images from Congregation of the Sacred Hearts United States of America Province (SS.CC. U.S.A. Province), you agree to be bound by the following Terms and Conditions as set forth below. Permission to reproduce and use images is valid pursuant to these Terms and Conditions.

2. If your actions are on behalf of your employer or another third party, then these Terms and Conditions shall apply to you and your employer and any other third party.

3. The term "images" refers to reproductions of still and moving images and/or copies of printed materials. Images are not to be used in any manner without the express and prior written permission of SS.CC. U.S.A. Province.

4. Nothing in these Terms and Conditions or in any other agreement with SS.CC. U.S.A. Province shall transfer any underlying rights to the images to you or to any third party. The images remain the physical property of SS.CC. U.S.A. Province and the intellectual property of the copyright holder, if applicable.

5. Failure to comply with any of the stated Terms and Conditions will result in immediate revocation of reproduction and permission.

COPYRIGHT NOTICE:

1. Images reproduced by the SS.CC. U.S.A. Province for you may still be under copyright and protected by the intellectual property laws of the United States Berne Convention. You are solely responsible for clearing the copyright with the rights holder. 2. SS.CC. U.S.A. Province makes no representation or warranties that it owns or licenses any such rights nor does SS.CC. U.S.A. Province grant you any rights including copyright, trademarks, or rights of publicity belonging to any person, place, property, or subject matter depicted in any image. SS.CC. U.S.A. Province makes no representation or warranty as to the accuracy of any information provided with the image.

3. You are solely responsible for determining whether your use of any image requires the consent of any third party or the license of any additional rights. You should not rely solely on information provided by SS.CC. U.S.A. Province. If you are unsure whether additional rights are needed for your use, you are responsible for consulting with legal counsel.

RELEASES AND PERMISSIONS:

1. Permission for reproduction of images is on a non-exclusive basis, for a geographical distribution limited to the territory in which permission is granted. SS.CC. U.S.A. Province reserves the right not to permit reproduction of any image for any reason whatsoever.

2. Manipulation of an image is subject to restrictions. Advance written permission is required to crop or use a detail from an image. An accompanying caption or label must be provided indicating any alterations made to the image, including tinting or detailing.

3. The credit must read: "[Photographer's name and/or Archives Document/Item No.], Congregation of the Sacred Hearts of Jesus and Mary U.S.A. Province Collection." It must accompany each reproduction of an image.

Images reproduced electronically on the worldwide web must contain the credit line as part of the image.

4. Verification that proper use and credit of images has been made requires that a copy of the completed project or publication be sent to the SS.CC. U.S.A. Province at no charge.

5. SS.CC. U.S.A. Province will not sign any submitted permission or licensing agreements from the requestor.

INDEMNIFICATION / LIMITATION OF LIABILITY:

1. You agree to hold SS.CC. U.S.A. Province, its officers, employees and agents harmless from any said and all claims and expenses arising from your use of an image.

2. Under all circumstances, SS.CC. U.S.A. Province's liability with respect to any image is strictly limited to the usage fee paid to SS.CC. U.S.A. Province by you in connection with such image.

PAYMENT TERMS:

1. Full payment of reproduction and usage fees to "Congregation of the Sacred Hearts U.S.A. Province" is required before permission is granted or images are released.

 Usage fees will be calculated based on information you provided in good faith.
Payment is not refundable. Default in payment will immediately revoke permission.

UNAUTHORIZED USE OF IMAGES:

In the event that you utilize any image without, and prior to, written permission from the SS.CC. U.S.A. Province, or you utilize any image for any use other than that indicated on the *Order Form for Purchase and Use of Images*, including but not limited to the number of uses, the publications utilized, or the size of reproduction, SS.CC. U.S.A. Province may, without limiting any of its rights hereunder or at law, charge you a liquidated damages fee equal to four (4) times the usage fee we would have charged for such use of the image.

NO WAIVER, COMPLETE AGREEMENT:

1. The terms set forth in this Terms and Conditions for Purchase and Use of Images form represent our entire agreement concerning the delivery of images to you and your usage thereof.

2. All prior understandings or representations, whether in writing or oral, based on "industry custom" or past dealings, are hereby merged with this Agreement. No terms or conditions may be added, removed, or modified unless made in writing and signed by both parties.

3. No action of SS.CC. U.S.A. Province, other than an express written waiver, may be construed as a waiver of any part of this Agreement, and no employee of SS.CC. U.S.A. Province is authorized to waive it orally. In the event that SS.CC. U.S.A. Province waives any specific part of this Agreement, it does not mean it waives any other part.

NOTICE: WARNING CONCERNING COPYRIGHT RESTRICTIONS
